Bookings are taken subject to the following conditions

Simply complete and return the booking form with your deposit and cancellation insurance fee if required. Bookings become firm when confirmed by us. We are pleased to accept telephone bookings. These are held provisionally for three days to allow your deposit to arrive.

The first person names on the booking form must be over 21 years of age and is responsible for the caravan and its contents.

Your final balance will be notified when we confirm your booking and must be received by us at least 4 weeks before your arrival date, otherwise we may retain your deposit and re-allocate your booking to another party. No further reminder will be sent and failure to take up occupancy does not relieve the hirer liability for the full balance due in respect of the holiday booked.

Cancellation insurance

£20.00 per caravan per week, payable with your deposit, covers the named persons on the booking form against death, illness, redundancy and jury service at least 48 hours before the start of your holiday. Insurance covers the return of your deposit (less £5 administration) and cancels any liability for the balance due. A doctor's certificate will be required for all claims.

Beds and Bed Linen

All of our caravans have duvets but bed linen is not provided, please bring your own towels, duvet covers, sheets and pillow cases. For those guests with babies and small children we now offer cots & Highchairs for hire at an extra cost of £10 per item.

Swimming pool

The pool is not open in the low season. Users of the swimming pool must be aware that the pool is

not supervised and use the pool at their own risk. Non-swimmers and children under the age of 18 years must be supervised by a responsible adult at all times.

Children

Parents are fully responsible for their children in all respects. Young children may not be left unattended. Where necessary please provide waterproof mattress covers.

Pets

Dogs and cats are only permitted in dog type caravans. Pets are not allowed in the park buildings or swimming pool area and must be kept on a lead and under control at all times. They must be exercised off the park to avoid fouling and must not be left unattended in or outside caravans. The management reserves the right to ask pet owners to leave the park immediately and without refund if any of these conditions are broken. Vacuum cleaners may be borrowed from the office during office hours to remove excess hairs.

Occupants

The stated number of berths must not be exceeded. Only families and couples are accepted, no single sex parties or groups of unaccompanied teenagers accepted. Children and babies each count as one person.
